From the Chairman's window.

About a year ago I ended a contribution at a meeting by saying, 'Beware of men with theodolites!'. Recently you may have seen activity on sites by the Bournemouth Road on the Blandford side. The field south of Newlands Manor has received 'outline' planning permission for 40 or so houses and part of the field opposite that is now being surveyed. People who live in and love our village have challenged efforts to get planning permission on our 'sacred' site by the church; my thanks too, to those who attended Parish Council meetings concerning this and the Hall and Woodhouse plan, and took the time to write to North Dorset Planning. This all comes in a week when parish councils have been assured by the Dorset Shadow Cabinet that their views will always be taken into account. It has long been regarded as a bit of a lottery when local opinion – not always 'nimby' – has been submitted and seemingly ignored. Maybe things are moving in the right direction.

The months ahead will bring a sea change when Brexit reaches its target date. That should coincide with the launch of the new Dorset County. On top of that, local elections take place on 2nd May. There has to be a greater awareness of what is happening locally and all those registered to vote should get out and play their part in our democratic process. It is depressing to hear that only 27% of voters turned out to vote in some wards.

The Parish Council is responsible for the QEII Playing Field, where trees are to receive attention and some refurbishment is in the offing in the Play Area, with a new piece of apparatus arriving for the younger ones. A safety covering is also being investigated to replace the bark.

Linked in with much of the above is the Annual Parish Meeting on Tuesday March 12th in the Church Room. This is an 'open house' and a chance just to listen, to sound off, or to praise! Local taxes (Council Tax and Parish Precept) have to be spent efficiently and you will be aware of the costs of running the police force. The first part of the evening from 7pm will involve a presentation by Dorset Police and the second half will be devoted to Council matters, with, hopefully, the outgoing Chairman of Dorset County Council, Cllr Hilary Cox, who is a very good friend of Charlton Marshall. Successful recipients of the Community Benefit Grant 2018 will also be unveiled.

If you are interested in becoming a councillor, or know someone who might just need some encouragement, now is the time to act; get the forms and send them off. Help us to meet your needs by supporting your local councillors and remember to vote on Thursday 2nd May.



Thursday May 2nd 2019 Elections for the new Dorset Council will take place.

Also, if we have more than 8 people nominated to become Parish Councillors, then you will also vote for them (fewer than 8 become councillors and thev without an election).

Register for this May's elections.

Do it now! Now is the time to ensure that your name is on the Electoral Register so that you can support your community and vote. You also need to be on the Register in order to become a Parish Councillor. Copies of the Electoral Register are kept at post offices and libraries, so check to make sure your name is there. You can also check by phoning North Dorset Electoral Services on 01305 838299 or email elections@dorset.gov.uk It's your right to vote, so don't miss out.

The Annual Parish Meeting on 12th March 2019 will provide an opportunity to find out more about what is involved in being a councillor and existing councillors will be on hand to answer any questions. See front page.
